Refuse and Recycling / Public Utilities / Franchise Committee: Brian Kerr, Chair of the Refuse and Recycling / Public Utilities / Franchise Committee made no report.

Mr. Mercer reported the committee agreed to amend a previous proposal that was waiting on second reading. That being a proposal to amend section 901.01 (e) (1), (2) and (3), and to repeal sections 901.09 (e) (4), (5) and (6).

Mr. Mercer also advised the committee agreed to pass on to the full council a proposed resolution to support The Ohio Commission for the United States Semi Quincentennial (America-250).

Mercer also reported the committee had along discussion regarding the outdoor alcohol consumption area and agreed to have a proposal prepared as soon as possible.

Mr. Mercer called the next meeting of the committee for 6pm Wednesday March 20, 2024, in chambers.

Recreation and Ordinance Committee: Thomas Clark, Chair of the Recreation and Ordinance Committee reported he had been in discussions with Service Safety Director Jones regarding applying for new playground equipment.

Streets / Lands and Buildings Committee: Scott Barrett, Chair of the Streets / Lands and Buildings Committee reported the committee met at 5pm Wednesday February 28, 2024, in chambers with all committee members present as well as several department heads and elected officials.

Safety and Rules Committee: Jeffrey Kreefer, Chair of the Safety / Rules Committee reported the committee met at 4pm Thursday February 15, 2024, in chambers, Byers with all committee members present as well as several department heads and elected officials.

Kreefer reported the committee took up several topics directed towards the fire and police departments, with the need for new hires, equipment needs and environmental issues in the forefront. Kreefer reported the meeting concluded at 4:50pm.

Mr. Kreefer reported that the committee met in special session at 5:50pm, just prior to this regular meeting of East Liverpool City Council with all committee members present as well as several department heads and elected officials with the committee taking up and agreeing to pass on to the full council a proposed resolution approving Columbiana County's 9-1-1 Final Plan. PLANNING DEPARTMENT: City Planning Director William Cowan reported to council he had been contacted by Marathon Oil to exempt the rail road crossing on Harvey Avenue as it is out of service and was advised to follow through with the exception.

Also, Cowan provided some information about the RAISE grant that he felt Council should be aware of, including the amount requested and time tables for construction.

In closing, Mr. Cowan requested any input for the Saint Claire Avenue Flood Study, indicating that information is available in his office.
